Correspondence Chairman Paul McGee reported no COD mail at Town Hall or home.

Accessibility Improve accessibility to Town sponsored events. The Thanksgiving Day Parade is sponsored by America's Hometown Thanksgiving Celebration (AHTC) which is a separate 501(c)(3). Emily suggested the COD should meet with them to ensure there is an ADA track for attendees around parking and other related concerns. Offer solutions to the concerns about specific events. Emily can assist with Town sponsored events, but the COD would need to reach out to those sponsoring public events not facilitated by the Town. Put together an action plan to outline things that do not support those with accessibility limitations to attend. Offer recommendations that can address those concerns.

Emily Wilson, Assistant Commissioner of Health and Human Services, suggested backup Meeting Minute taker similar to having a backup host for the meetings. Lissa was identified as the backup host during the meeting. Once the Town Clerk sets up an account for Lissa, she will be able to facilitate the COD meeting if Emily is absent.

Emily was contacted by MassAbility, formerly known as Mass Rehabilitation Commission. They wish to attend the next Commission meeting to present information about what their agency does and hope to partner with the COD.

Emily reported a budget of \$350 was earmarked for the Commission for materials and supplies. It could be requested for purchasing items such as the plaque that was previously discussed by the Commission for the Poet Laureate for their work on the White Horse Beach mobi-mat dedication.

The plaque wording at Stephen's Field acknowledging the COD was corrected and will be reinstalled soon. Also, due to the timing of the park opening, limited plantings could be made. Moving forward, more plantings will be added to increase shade at the park.

2024 Beach Report to review beach accessibility features like the mobi-mat. Review the report and provide feedback. The Parks & Forestry and Recreation Departments were made aware of the concerns with the accessible bathroom at White Horse Beach not working often. Please keep them up to date real-time so they may address the issue in a timely manner.

The Town of Plymouth received \$250K from the MOD Municipality ADA Grant to assist in the restructuring of the Center for Active Living parking lot. This will allow for improved grading, access aisle, handrails and additional parking spots. All work being paid by the grant need to be completed by June 30, 2025.

The current COD grant balance per the Finance Office is \$84,515.15.
