Resurfacing of the track now will help to prevent significant issues that would lead to a premature replacement of the entire track. There are significant pieces of the track surface coming up causing safety concerns.

Running Track Resurfacing Proposal  
Plymouth, MA  
(Two-Tone Dark Blue / Light Blue Installation)

Cape & Island Tennis & Track is pleased to present the following proposal for the installation of an all-weather track resurface at Plymouth North High School in Plymouth, MA. Prices are based on the NCPA (National Cooperative Purchasing Alliance) program. NCPA provides competitively solicited pricing for preferred products and services. Because these products and services have been bid at a national level, individual public entities do not need to duplicate their own bid process.

The existing track surface is a Beynon BSS-100 polyurethane paved mat, structural spray system. The proposed method of resurfacing is the standard industry method for resurfacing this type of running track.

Protect adjacent synthetic turf field, sidewalks and fencing.


**Polyurethane Structural Spray**

Provide and install two coats of Dark Blue and Light Blue Waterborne Aliphatic Polyurethane Structural Spray at a total rate of 3.6 lbs per square yard to existing track surface area. Coating consists of .5-1.5mm EPDM rubber granules and red pigmented aliphatic polyurethane. Dominant track color will be dark blue. 4x100M Exchange

zones, pole vault and long jump runways to be light blue. Manufactured by Beynon Sports Surfaces; Hunt Valley, MD.

Surface Project Managed by *ASBA Certified Track Builder*  
Line striping and marking track, including all existing lettering and markings.
