LOCAL REGULATIONS BY SELECTMEN FOR LICENSED PEDDLERS

In accordance with Chapter 101 of the General Laws, the following regulations are hereby adopted:

The following areas are prohibited for the sale of goods and food by peddlers, hawkers, solicitors, and transient vendors:

1. Route 44, from Court Street to Route 80
2. Waterfront area, from Nelson Park to Steven's Field, including North and South Park Avenue, Water Street, Union Street, Lothrop Street, Chilton Street, Howland Street, Middle Street, Leyden Street, Bradford Street, Brewster Street, North Street, Lincoln Street and Fremont Street.
3. Court Street, from the Kingston Line south to North Street.
4. Main Street
5. Main Street Extension
6. Sandwich Street, south to Lincoln Street
7. Also included in this list are Morton Park, Plymouth Beach, and the Steven's Field areas.
8. The Selectmen may grant variances from these regulations if they deem it to be in the best interests of the Town.



Peddlers and Hawkers are not allowed (moving, stopped or parked) to operate on streets, private property or public property in the RED areas.









SUBJECT: AMENDMENT TO SELECTMEN'S POLICY ON MOBILE FOOD VENDING
IN THE DOWNTOWN/WATERFRONT DISTRICT

DATE: JUNE 18, 2018

Please be advised that, at its meeting of May 22, 2018, the Board of Selectmen voted to amend Section 2 of its Local Regulations for Licensed Peddlers, Vendors, Hawkers, Solicitors and Transient Vendors with the addition of the following language, as shown below, to allow for a pilot program at Nelson Memorial Park which would allow transient food vendors—specifically, food trucks—under the regulated provisions of a contract with the Town.

"The following areas are prohibited for the sale of goods and food by peddlers, hawkers, solicitors, and transient vendors:

2. *Waterfront Area, from Nelson Park to Stephens Field, including North and South Park Avenue, Water Street, Union Street, Lothrop Street, Chilton Street, Howland Street, Middle Street, Leyden Street, Bradford Street, Brewster Street, North Street, Lincoln Street and Fremont Street , with the specific exemption of a designated area within Nelson Memorial Park, for which the Town will allow transient/mobile food vending (a.k.a. food trucks) exclusively by contract. "*

Consistent with the amendment, the Town has granted a license agreement and exclusive vending rights to the Plymouth Area Chamber of Commerce to serve as the vendor for concessions at Nelson Memorial Park. As part of the license agreement, the Town will allow the Chamber to subcontract with a concessionaire and various mobile food vendors to operate at Nelson Park for a defined season, which shall begin as soon as possible and extend through Labor Day.

Mobile food vendors, under a contract and schedule with the Chamber, shall be allowed to park in two specifically-designated parking spots at Nelson during the defined season. No other vendors shall be allowed at any time during the season. Outside of this licensed/contractual season, mobile vending will be prohibited, unless under the umbrella of a Special Event Permit.
