### Frequently Asked Questions

#### Introduction

The Town of Plymouth is taking part in a National Opioid Settlement reached by the Massachusetts Office of the Attorney General and several opioid manufacturers and distributors. This settlement makes funds available to individual municipalities across the Commonwealth, which are required to adopt strategies for expanding opioid prevention, treatment, recovery, and harm reduction services in the communities they serve. In response, the Plymouth Opioid Remediation Project will launch in January 2024. Please see below answers to frequently asked questions.

#### Frequently Asked Questions (FAQs)

##### **▪ *What is the background/purpose of the Plymouth Opioid Remediation Project?***

Following formal acceptance of opioid settlement funds at the Fall Town Meeting in fiscal year (FY) 2024, the Plymouth Department of Health and Human Services (HHS) developed a project to generate community-driven solutions for reinvesting the settlement funds. The project is part of a coordinated response to the local opioid epidemic and aims to increase community engagement around the topic of opioids while enhancing related services for residents. Project components include: 1) gathering input from Plymouth residents/stakeholders; and 2) making funds available through a competitive grant program to local nonprofits that will provide opioid prevention, treatment, recovery, and harm reduction services in Plymouth as directed by the settlement.

##### **▪ *How can I provide input on the Plymouth Opioid Remediation Project?***

Plymouth HHS is holding two community meetings in January 2024:

- **Community Meeting #1 will be held on Wednesday January 24<sup>th</sup> from 9:30-11:00am in the Great Hall at [Plymouth Town Hall](#) in-person and [via Zoom at this link](#).**
- **Community Meeting #2 will be held on Thursday January 25<sup>th</sup> from 4:00-5:30pm in the Fehlow Room at the main branch of the [Plymouth Public Library](#) in-person only.**

Plymouth residents and local community partners are invited to attend and share how the opioid epidemic has impacted them, and their ideas/recommendations for investing the opioid settlement funds in Plymouth. The information gathered at these meetings will be integrated into Plymouth's coordinated response to the opioid epidemic, including the Opioid Remediation Project's competitive grant program for nonprofits that serve individuals and families.

##### **▪ *Who can apply for funding from the Town of Plymouth's Remediation Project?***


At this time, registered 501(c)3 nonprofit organizations that provide opioid-related services to Plymouth residents are eligible to apply for funding through Plymouth's competitive grant program. The request for proposals (RFP) will be released on **Thursday February 1, 2024**, and applications will be due back for consideration by **Friday March 1, 2024**. The RFP and instructions will be shared and posted on the [Town of Plymouth's website](#) as soon as details become available.

## HHS Quick Guide for Potential Opioid Remediation RFP Applicants

The Plymouth Department of Health and Human Services (HHS) has prepared this Quick Guide for potential applicants to the Opioid Remediation Project Request for Proposals (RFP), which will be released on February 1, 2024. **This Quick Guide is intended to serve as an at-a-glance resource for potential RFP applicants. This document is not an exhaustive list of information or requirements, so all potential RFP applicants should review the full RFP when it becomes available on February 1, 2024.**

### Who is Eligible?\*

Registered 501(c)3 nonprofit organizations and government entities that provide opioid-related services to Plymouth residents are eligible to apply for one year of funding through this grant program. Joint proposals between eligible entities will also be considered for this RFP. Applicants must serve Plymouth residents directly. Proposals that include subcontractors are not eligible for this program. **To be eligible, nonprofit applicants and government entities must propose to provide at least one type of opioid-related strategy that falls under seven specific strategy categories defined by the [Massachusetts State Subdivision Agreement](#), including (see Attachment 1):**

1. Opioid Use Disorder Treatment
2. Support for People in Treatment and Recovery
3. Connections to Care
4. Harm Reduction
5. Address the Needs of Criminal-Justice-Involved Persons
6. Support Pregnant or Parenting Women and Their Families, Including Babies with Neonatal Abstinence Syndrome
7. Prevent Misuse of Opioids and Implement Prevention Education

### Use of Grant Funds\*

Registered 501(c)3 nonprofit organizations and government entity applicants selected as grantees must use funds to provide at least one type of opioid-related strategy defined by the Massachusetts State Subdivision Agreement referenced above. **Please note that per the Massachusetts State Subdivision Agreement, grants cannot be used to fund direct services already reimbursed by the Commonwealth of Massachusetts, including through MassHealth and the Bureau of Substance Addiction Services (BSAS). Agencies that receive reimbursement for services can apply for funds to implement strategies not already funded/reimbursed by the Commonwealth.**

### Funding Commitments for Selected Grantees\*

#### **Eligible applicants selected as grantees will be required to:**

- ✓ Complete a Grant Agreement with the Town of Plymouth, including all required documentation.
- ✓ Implement a project that consists of at least one opioid-related strategy for Plymouth residents as defined in the Massachusetts State Subdivision Agreement (see Attachment 1).
- ✓ Complete four brief quarterly project reports, which will include but may not be limited to providing Plymouth HHS with information about how strategies/services were implemented, how funds were spent, and progress on any stated project goals and objectives.
- ✓ Complete a final report and provide additional information/updates as requested by HHS.

## Introduction

The Town of Plymouth is taking part in a [National Opioid Settlement](#) reached by the Massachusetts Office of the Attorney General (AG) and several opioid manufacturers and distributors. This settlement makes funds available to individual municipalities across the Commonwealth, which are required to adopt strategies for expanding opioid prevention, treatment, recovery, and harm reduction services in the communities they serve. In response, the Plymouth Department of Health and Human Services (HHS) launched an Opioid Remediation Project in January 2024. The Project is part of a coordinated response to the opioid epidemic and aims to increase direct community engagement on opioids while enhancing related services for residents. One of the Project's goals is to award grant funds through a competitive request for proposals (RFP) to local nonprofits and government entities that will provide opioid-related services.

This RFP was developed with specific input from Plymouth residents, nonprofit service providers, and professionals with grants/other subject matter expertise. Plymouth residents and Plymouth nonprofit service providers attended two Community Meetings on Opioid Remediation that were held by Plymouth HHS in late January 2024. Participants at the meetings were asked to share how the opioid epidemic has impacted them, and their recommendations for how settlement funds could be reinvested in the community to address the needs of Plymouth individuals/families facing opioid use. The current RFP is the Town of Plymouth's first funding cycle using opioid settlement funds, and more funding may become available in future cycles through grantmaking and/or other Town or regional programs.

## Background & Purpose

State attorneys general across the U.S. have recently settled and/or are in the process of settling historic opioid-related lawsuits with major opioid manufacturers and distributors. To date, it is estimated that these settlements will yield approx. 26 billion dollars awarded to 46 states as part of the [National Opioid Settlement](#). Massachusetts stands to receive over \$525 million from participation in these settlements over the next several decades.<sup>1</sup> The Town of Plymouth stands to receive a few million dollars over several years based on current projections.<sup>2</sup> On the state level, 60% of funds will be retained by the newly established [Massachusetts Opioid Recovery and Remediation Trust Fund](#) for statewide use. On the local level, 40% of funds will be distributed by the state for use by individual municipalities under a [State-Subdivision Agreement](#). The State began disbursement of funds to municipalities in FY 2023.<sup>3</sup>

In Plymouth, funds were received on a rolling basis over a period from FY 2023 to FY 2024. Funds were formally approved by Town Meeting via a Special Article Process in FY 2024, as required by the most current regulations at the time. Since funds were approved at Town Meeting, Plymouth HHS has been designated as the department responsible for administering a process to engage the community for direct input, issue an RFP, and select nonprofit and/or government entity partners to provide high-quality opioid prevention, harm reduction, recovery, and treatment services to Plymouth residents in accordance with the Massachusetts State-Subdivision Agreement.

### I. Eligibility

---

At this time, registered 501(c)3 nonprofit organizations and government entities that provide opioid-related to Plymouth residents are eligible to apply for funding through this competitive grant program. Joint proposals between eligible entities will also be considered for this RFP. This current RFP funds projects for the duration of one year. Proposed project budgets should not exceed \$50,000. Applicants must serve Plymouth residents directly. Proposals that include subcontractors are not eligible.

To be eligible, applicants must propose to provide at least one type of strategy that falls under seven specific strategy categories as defined by the [Massachusetts State Subdivision Agreement](#), including:

1. Opioid Use Disorder Treatment
2. Support for People in Treatment and Recovery
3. Connections to Care
4. Harm Reduction
5. Address the Needs of Criminal-Justice-Involved Persons
6. Support Pregnant or Parenting Women and Their Families, Including Babies with Neonatal Abstinence Syndrome
7. Prevent Misuse of Opioids and Implement Prevention Education

**NOTE: Per the [Massachusetts State Subdivision Agreement](#), grants cannot be used to fund direct services already reimbursed by the Commonwealth of Massachusetts, including through MassHealth and the Bureau of Substance Addiction Services (BSAS). Agencies that receive reimbursement for services can apply for funds to implement strategies not already funded/reimbursed by the Commonwealth.**

### II. Funding Requirements

---

Nonprofit organizations and government entities selected to receive funding will be required to complete the following activities:

- ✓ Complete a Grant Agreement with the Town of Plymouth, including all required documentation.
- ✓ Implement a project that consists of at least one opioid-related strategy for Plymouth residents as defined in the Massachusetts State Subdivision Agreement (Attachment 1), including prevention, harm reduction, recovery, and/or treatment services.
- ✓ Complete four brief quarterly project updates, which will include but not be limited to providing Plymouth HHS with information about how strategies/services were implemented, how funds were spent, and a description of progress towards any stated project goals/objectives.
- ✓ Complete a brief final report summarizing how project goals were achieved.
- ✓ Respond to any additional requests for information from HHS as needed for state reporting, etc. (The Town of Plymouth reserves the right to visit site and/or request additional information.)

### III. Scoring Process & Criteria

---

Applications for this RFP will be reviewed, scored, and considered by an Opioid Remediation RFP Review Committee that consists of members with relevant process/subject matter expertise. The RFP Review Committee is responsible for reviewing, scoring, and providing final funding recommendations on the merits of each application to Plymouth HHS. Only applicants that meet eligibility criteria, commit to funding requirements, and provide complete information for each element listed below will be reviewed and scored by the Committee.

#### Application Elements:

1. Applicant Organization Information (organization name, contacts, etc.)
2. Brief Organization Overview
3. Brief Project Narrative (including Statement of Commitment to Funding Requirements)
4. Project Timeline (Appendix A)
5. Project Budget (Appendix B)
6. Letter of Support (Appendix C)
7. Additional Documents (Appendix D)

#### Important Scoring Notes:

- ✓ Applicants will be selected based on the extent that they provide clear information/responses to each element above.
- ✓ Reviewers will also consider the extent to which each applicant provides a clear description of how their project will foster access and promote equity among vulnerable and underserved community members and/or groups in Plymouth.
- ✓ Reviewers will also consider the extent to which each applicant proposes strategies that are evidence-based.

### IV. Rejection of Proposals

---

The Town of Plymouth does not promise to accept the lowest cost proposal and specifically reserves the right to reject any or all proposals or parts thereof in its sole discretion, to waive any formal proposal requirements, to investigate the qualifications and experience of any applicant, to reject any provisions in any proposal, to obtain new proposals, to negotiate the requested services and contract terms, and to adjust funding amounts with any applicant. The Town of Plymouth further reserves the right to insist on or waive any technicalities required for the best interest of the Town. If all proposals are unacceptable, the Town reserves the right to reject all proposals, to issue a new Request for Grant Proposals, or to determine to spend the Opioid Settlement funds in any way permitted by law and the terms of the settlement, whether or not through solicitation of proposals or otherwise. Incomplete proposals and proposals not sufficiently detailed or not in acceptable form may be returned for completion or may be rejected by the Town of Plymouth.

### **V. Indemnification**

---

To the fullest extent permitted by law, the Grantee agrees to indemnify and hold harmless the Town of Plymouth and all of its employees, officers, and agents (collectively, "Indemnified Persons") from and against any and all losses, costs, damages, expenses, judgments, and liabilities of whatever nature (including, but not limited to, attorneys', accountants' and other professionals' fees and expenses, litigation and court costs and expenses, amounts paid in settlement and amounts paid to discharge judgments and amounts payable by an Indemnified Person relating to or arising out of (i) the actual or alleged failure of the Grantee to comply with the terms of this Agreement or with any other requirement or condition applicable to the grant with which any Grant is funded or (ii) the operation or undertaking of each Project; provided that no indemnification shall be required of an Indemnified Person to the extent such losses are determined by the final judgment of a court of competent jurisdiction to be the result of the gross negligence or willful misconduct of such Indemnified Person. Such indemnification includes, but is not limited to, costs arising from third-party claims. The provisions of this Section shall survive the termination of this Agreement, and the obligations of the Grantee hereunder shall apply to losses or claims whether asserted prior to or after the termination of this Agreement. In the event of failure by the Grantee to observe the covenants, conditions and agreements contained in this Section, any Indemnified Person may take any action at law or in equity to collect amounts then due and thereafter to become due, or to enforce performance and observance of any obligation, agreement or covenant of the Grantee under this Section. The obligations of the Grantee under this Section shall not be affected by any assignment or other transfer by the Town of Plymouth of its rights or interests under this Agreement and will continue to inure to the benefit of the Indemnified Persons after any such transfer. The provisions of this Section shall be cumulative with and in addition to any other agreement by the Grantee to indemnify any Indemnified Person.

### **PLYMOUTH DEPARTMENT OF HEALTH AND HUMAN SERVICES ANNOUNCES NEXT STEPS ON OPIOID INITIATIVES**

[PLYMOUTH, MA] – The Plymouth Department of Health and Human Services (HHS) is pleased to announce a new name and next steps for the Plymouth Addiction Response and Improvement Strategies Effort (Plymouth ARISE), formerly known as the Town's Plymouth Opioid Remediation Project. Led by HHS, Plymouth ARISE is the Town's coordinated response to the local opioid/substance use epidemic and the opioid settlement reached by the Massachusetts Office of the Attorney General with opioid manufacturers/distributors. This settlement makes funds available to participating municipalities across the Commonwealth of Massachusetts, which are required to adopt strategies for expanding opioid prevention, treatment, recovery, and harm reduction services in the communities they serve.

Plymouth ARISE aims to increase community engagement and reduce stigma around the topic of opioid and other substance use, while enhancing related services for residents. In January 2024, HHS held two well-attended community meetings for Plymouth residents and local community partners. Individuals, families, and community stakeholders were invited to attend these open forums and share how the opioid epidemic has impacted them, as well as their ideas/recommendations for investing the opioid settlement funds in Plymouth. The information gathered at the community meetings was directly integrated into components of Plymouth ARISE, including a competitive grant funding program.

On February 1, 2024, HHS issued a request for proposals (RFP) that called for Plymouth-serving nonprofits and government entities to propose opioid service-enhancement projects for individuals and families in accordance with the settlement requirements. Proposals were then evaluated and scored by an independent RFP Review Committee comprised of volunteer community-based, subject matter experts. HHS is proud to share that we received a number of impressive proposals and several grantees have been selected to receive funding pending execution of a formal contract with the Town. Plymouth ARISE Grantees include Bay State Community Services, Brockton Area Multi-Services, Inc. (BAMSI), High Point Treatment Center, Plymouth Public Schools, and To The Moon and Back. HHS looks forward to issuing further updates and recognizing Plymouth ARISE Grantees at a formal ceremony in May 2024.

HHS is committed to investing in many impactful programs to address the opioid epidemic through Plymouth ARISE. This week, HHS is participating as an American Public Health Association Local Partner in National Public Health Week, which begins Monday April 1<sup>st</sup>. 

## Jump Start

Jump Start Funding of \$15,000.00 is intended to support any Plymouth youth impacted by opioid use disorder (OUD). It works to identify and break down barriers and fill gaps within traditional scholarships in accessing higher education and/or career development.

Youth are not required to attend Plymouth Public Schools; however, ***they must be residents of Plymouth and have been impacted by OUD in compliance grant requirements.*** Impact may be direct to the individual or through a family member or caretaker that is actively struggling with or in recovery from OUD.

Any request for funding must be submitted with a completed application to be distributed to the committee for review and approval. Information contained in the application may be discussed by the review committee as part of this process; however, it should not be shared outside the group, unless by consent.

Funding is considered and approved on a case-by-case basis to accommodate the unique needs of applicants. Each application will have a date that funds are needed, so prompt review and feedback of applications will be helpful. If approved, an award letter will be sent to both the referral source as well as the applicant.
