2026 Senior & Veterans Property Tax Work Off Program

FACT SHEET

- ◆ PARTICIPANTS MUST WORK A MINIMUM OF 10 HOURS IN ORDER TO RECEIVE CREDIT.
- ◆ TO OBTAIN THE MAXIMUM \$1,500 CREDIT (\$15.00 PER HOUR) A TOTAL OF 100 HOURS OF VOLUNTEER WORK IS REQUIRED.
- ◆ IN ORDER TO QUALIFY, THE FOLLOWING CONDITIONS MUST BE MET:
 - ◆ APPLICANTS MUST BE AT LEAST 60 YEARS OLD BY JANUARY 1, 2026 **AND/OR** A VETERAN (ANY AGE) AS DEFINED BY MGL C.4, SECTION 7, CLAUSE 43
 - ◆ A SPOUSE MAY BE AN "APPROVED REPRESENTATIVE" TO PERFORM THE WORK IN THE CASE OF A DISABLED VETERAN PHYSICALLY UNABLE TO DO THE WORK
 - ◆ A HOMEOWNER IN PLYMOUTH LISTED ON THE DEED/ YEAR-ROUND RESIDENT
 - ◆ MUST OCCUPY THE PROPERTY FOR WHICH THE TAXES ARE PAID
- ◆ ONLY ONE MEMBER OF A HOUSEHOLD IS ELIGIBLE FOR PARTICIPATION IN THE SENIOR/VETERAN TAX CREDIT PROGRAM EACH YEAR.
- ◆ THE AMOUNT OF THE TAX REDUCTION IS NOT SUBJECT TO MASSACHUSETTS PERSONAL INCOME TAX BUT IS SUBJECT TO MEDICARE AND SOCIAL SECURITY TAX, AND MAY BE SUBJECT TO FEDERAL INCOME TAX.
- ◆ CREDIT WILL BE ISSUED TO YOU IN THE FORM OF AN EXEMPTION ON YOUR PROPERTY TAX BILL DECEMBER 2026
- ◆ THE TOTAL CREDIT OF THE EXEMPTION WOULD EQUATE TO THE AMOUNT EARNED LESS MEDICARE, FEDERAL INCOME TAX, AND SOCIAL SECURITY TAX.
- ◆ PARTICIPANTS MUST BE IN GOOD STANDING WITH ALL TAXES, UTILITIES, AND EXCISE
- ◆ PARTICIPANTS ARE RANDOMLY SELECTED BY LOTTERY FOR THE PROGRAM; BACKGROUND CHECKS ARE **MANDATORY**.
