

### **CAMPAIGN FINANCE REPORTS FORM – CPF M102**

<b>Pre-Election Report</b>	Due 8 <sup>th</sup> Day Preceding Election - <b>Friday, May 8</b>	Period: Jan 1 - Apr 28
<b>Post-Election Report</b>	Due 30 <sup>th</sup> Day After Election - <b>Monday, Jun 15</b>	Period: Apr 29 – Jun 5
<b>Year End Report</b>	Due End of Year - <b>Wednesday, Jan 20, 2027</b>	Period: Jun 6 – Dec 31

If you do not have a political committee, campaign fund, or any spend and/or fundraising activity in connection with your campaign, you may sign Form CPF M102-0 (available at the Town Clerk's Office) for each reporting period in lieu of filing [Form CPF M102](#). Candidates with no committee, campaign fund or intended spend/fundraising activity may also file [Form CPF M109](#) at the beginning of the year to fulfill all reporting requirements within the calendar year.

**Year-end reports must be filed by all townwide candidates & elected officials each year.**

# Checklist for Running for Local Office

- Review Positions on Ballot / Terms Due to Expire** for list of positions available on this year's ballot.
- Review Annual Political Calendar.** Note the timeline to complete nomination papers.
- Obtain Nomination Papers** and complete the **Candidate Interest Form** at the Town Clerk's office. Circulate papers for qualified signatures from registered voters. The required number of signatures for townwide candidates is set at 1% of the total number of voters in the Town of Plymouth who voted in the last race for Governor. The total number of voters in the 2022 State Election in Plymouth was 29,238. MGL Ch 53, §6 states the # of signatures required cannot be less than 20 and no more than 50.


**Candidates for townwide office will need 50 signatures** from any registered Plymouth voter and **candidates for Town Meeting Member need 10 signatures** from registered Plymouth voters *in their precinct*.

All signatures must be legible and written substantially as registered. Regulations allow a voter to insert or omit a middle name or initial OR use a common nickname and still have their signature deemed valid. It is strongly recommended candidates collect 50% more signatures than required to account for non-certifiable names.

- Return Nomination Papers** to the Town Clerk's office by Friday, March 27 and complete the **CPF M101: Statement of Organization Form**.
- Submit Campaign Finance Reports**  
State law requires an accounting of all money received or spent throughout a political campaign. Townwide candidates are required to submit regular [Form CPF M102](#) campaign finance reports to the Town Clerk's Office and to comply with campaign finance laws and procedures. Town Meeting Members are exempt from these reporting requirements. Candidates are encouraged to use [OCPF's online reporting tool](#) for clear, effective reporting. The 2026 filing schedule is as follows:
  1. **8 days before the town election** – May 8th, 2026 (reporting period: January 1<sup>st</sup> to April 28th)
  2. **30 days after the town election** – June 15th, 2026 (reporting period: April 29<sup>th</sup> to June 5th)
  3. **End of year report for 2026** – Due January 20th, 2027 (reporting period: last day of previous report to December 31st, 2026 *OR* January 1st, 2026 to December 31st, 2026)

Please review the [Campaign Finance Guide for Municipal Candidates](#) via the Office of Campaign and Political Finance (OCPF) website. It is the responsibility of all those participating in political campaign financing in Massachusetts to become knowledgeable with the provisions of the law and its regulations. Violations of the law carry serious penalties of fines, imprisonment or both.

# Overview of Elected Positions in the Town of Plymouth

## Select Board

- # of Positions: 5 townwide members
- Term: 3 Years
- Duties\*: The Select Board is the chief executive body of the Town. Their general powers and responsibilities are to: adopt policy directives and guidelines for the Town, review the annual proposed operating and capital budgets submitted by the Town Manager, make appointments to various boards, committees and offices, ensure efficient and orderly operation of all town agencies, etc. Preview recent [Select Board agendas](#) to learn more.
- Meeting Schedule\*\*: Once a week

## School Committee

- # of Positions: 7 townwide members
- Term: 3 Years
- Duties: Their general responsibilities are to: oversee the annual school budget, develop school system policies, hire and review the performance of the Superintendent of Schools, and advocate for the school system with citizens and Town Government. Preview recent [School Committee agendas](#) to learn more.
- Meeting Schedule: Twice a month

## Town Moderator (*Not up for election in 2026*)

- # of Positions: 1 townwide position
- Term: 3 Years
- Duties: Their general responsibilities are to: assist in the planning of, participate in the agenda setting for and preside over all Town Meeting sessions; cast the tie-breaking vote at Town Meetings when necessary. Preview recent [Town Meeting reports](#) to learn more.
- Meeting Schedule: Two Town Meetings per year, 1<sup>st</sup> Saturday in April and 3<sup>rd</sup> Saturday in October, and any other Town Meeting called by the Select Board

## Planning Board

- # of Positions: 5 townwide members
- Term: 5 Years
- Duties: Their general responsibilities are to: review plans for public land use and division and specific development and zoning proposals. Preview recent [Planning Board agendas](#) to learn more.
- Meeting Schedule: Twice a month

## **Housing Authority**

- # of Positions: 3 townwide members (plus 1 tenant member and 1 state-appointed member)
- Term: 5 Years
- Duties: Their general responsibilities are to: operate, maintain, promote and provide quality, affordable and safe housing for families or elderly persons of low income and prepare plans for the clearance of decadent, substandard or blighted open areas. Preview recent [Housing Authority agendas](#) to learn more.
- Meeting Schedule: Once a month

## **Redevelopment Authority**

- # of Positions: 4 townwide commissioners (plus 1 state-appointed member)
- Term: 5 Years
- Duties: Their general responsibilities are to: improve housing ownership, redevelop public and private parcels, and provide rehabilitation assistance to substandard properties in the community. Preview recent [Redevelopment Authority agendas](#) to learn more.
- Meeting Schedule: Once a month

## **Town Meeting Member**

- # of Positions: 162 precinct-level members, 9 per precinct
- Term: 3 Years
- Duties: Town Meeting is the chief legislative body of the Town. Their general responsibilities are to: consider major town financial proposals and pass a balanced annual town budget, approve charter revisions, and enact all town bylaws. Preview recent [Town Meeting reports](#) to learn more.
- Meeting Schedule: Two Town Meetings per year (the 1<sup>st</sup> Saturday in April and the 3<sup>rd</sup> Saturday in October) and any other Town Meeting called by the Select Board. Some precinct caucuses meet once a month.

*\*\*Meeting schedules are meant only to give a general idea of time commitments and are subject to change and/or additional requirements.*

# Election Day Reminders

## **Adhere to Campaign Activity Rules**

On Election Day, political signs must be held by a person at polling locations. No signs may be put into the ground, hung on fences or left on public property per Zoning Bylaw §203-3, C(4).

**No Campaigning – or any action intended to influence the vote of a voter – for any candidate or ballot question on the ballot is allowed within 150 feet of any entrance to the polling location** per MA General Law Chapter 54, Section 65. Prohibited actions include but are not limited to:

- holding or distributing any campaign materials
- wearing any campaign garb with identifying signage or slogans
- soliciting a person's vote for or against a candidate or question on the ballot
- distributing ballot stickers
- vehicle bumper stickers

Voters must remove any political or campaign garb in violation of this statute prior to entering the polling place. Those who do not will be asked to remove and/or cover the items by the warden or return when they are able to comply with the law.

Extended time talking with election workers or other residents in the polling location after you have voted may appear to be campaigning.

## **Election Results**

Unofficial results are posted on election day after polls close. Precinct-level results are available immediately and publicly posted at their respective polling location. Townwide results are consolidated and posted online to the town's website typically later in the evening once they are returned to the Town Clerk's Office.

Official results are certified, submitted to the state and posted online by the Town Clerk after the election in accordance with MA General Law.
